CONSENT AGENDA:

Councilmember Richard Bracknell motioned to approve the consent agenda; seconded by Councilmember William Simmons. Motion carried 5-0

NEW BUSINESS:

- 1.) **Recognition of the Citizen of the Month:** Peggy Carnes from the Temple Senior Center
- 2.) **Recognition to the Temple Wastewater Treatment Plant:** The Georgia Association of Water Professionals is pleased to present the GOLD AWARD to the Wastewater Plant for complete and consistent permit compliance during the calendar year of 2010. This is the 5th year in a row the wastewater plant has received this award. Upon accepting this award David Henson, the Director at the Wastewater Plant stated he will do his best to receive the Platinum Award next year.
- 3.) **Recognition to the City of Temple for the 2011 Community Award for Beautification:** This was awarded to the City for the Gateway Project: New signage and Landscaping at the intersection of Villa Rosa Road and Carrollton Street. The City of Temple was awarded the silver award for beautification for the landscaping that was done around the “Welcome to Temple” sign near the truck stop.
- 4.) **Recognition of the City of Temple’s City Attorney Cynthia Daley:** Mrs. Daley was included on the list of 2011 GEORGIA SUPER LAWYERS RISING STARS.
- 5.) **Project Proposal for emergency generators for the Center Point Lift Station and Billing Road Lift Station:** This would provide protection for two (2) lift stations within our system that have limited wet well space and cannot withstand prolonged power outages without overflowing. Upon discussion Council Member Terron Bivins motioned to approve the purchase of the (2) used generators in the amount of \$43,770; seconded by Council Member Jay Mann. Motion carried 5-0
- 6.) **Request to Pre-Purchase supplies for the Villa Rosa Force Main Project:** Council Member Richard Bracknell motioned to pre-purchase the supplies for the force main project. The pre-purchase of these supplies will save the City over \$17,000; seconded by Council Member Jay Mann. Motion carried 5-0
- 7.) **Approval of Contract for Sage Street Sidewalk Project:** Council Member Richard Bracknell motioned to remove this item from the agenda; seconded by Council Member William Simmons. Motion carried 5-0
